n a recent presentation with campus partners, FS shared updates regarding its Zero Waste initiatives. See the presentation at bit.ly/3Ve9XgA.

Zero Waste aims to keep UCR's waste from going to landfills.

UCR is currently **diverting over 50%** of the municipal waste previously sent to landfill.

FS's recycling and refuse team services the entirety of campus including apartments, residence halls, and dining facilities. The four-person team administers over 350 dumpsters and 7 compactors on campus.





he Landscape Services team assisted students and alumni during the Highlander Day of Service. This year's project was to install mulch on the west side of the Humanities, Arts, and Social Sciences building. Adding mulch to this planter allows FS to add organic

material, reduce the use of water, and suppress unwanted weeds and grass. Staff, students, and alumni worked together to help spread and level the mulch. Thanks to the many helping hands, anyone on West Campus Drive will be able to see the improved landscape area.
