

Facilities Services is providing the following guide to assist UCR departments with purchasing disinfectant supplies and other PPE.

Below are details of the items available for order and instructions are on the backside of this document. Please work with your purchasing unit for the buying process in your organization.

Supply Options

Ready to Use Disinfectant



- 24-32 ounces.
- Should be on the EPA's List N, the approved list of products for use against SARS-coV-2, the virus that causes COVID-19.
- The least hazardous products do not require PPE (Botanical & Alcohol based products).
- No PPE required.
- If you are only able to find products by the gallon, you will need to purchase empty bottles with a trigger sprayer.

Disinfecting Wipes



- The least hazardous products do not require PPE (Hydrogen Peroxide based products).

Hand Sanitizers



- Bottles usually come in 4oz, 8oz and 16oz with pump.
- Refills should be compatible with dispensers.
- Must contain at least 60% Ethyl Alcohol.

Gloves and Face Coverings



- Gloves – Nitrile is probably the most durable, however, Vinyl and Powder-Free Latex could also be options.
- Eye Protection – Eye Goggles or Safety Glasses.
- Disposable, non-medical grade face masks for one-time use.
